

Objective

The Growth/Income allocation is designed to generate capital appreciation. Current income is a secondary objective.

Philosophy

The Growth/Income allocation is invested approximately 57% in stocks and 43% in bonds and cash. Both the stock and bond allocations are broadly diversified across different asset classes and managers. The diversification is



designed to lower the expected volatility of the portfolios' returns and help protect against negative marketing environments. The U.S. and international stock allocations have a value orientation to potentially reduce portfolio volatility and downside risk.

Implementation

TIAA Kaspic implements the allocation using an array of carefully screened, low-cost mutual funds. The portfolio is maintained in a custody account at Charles Schwab & Co., Inc., and is rebalanced periodically.
